<b>What is the overall deductible?</b>	\$4,000/person or \$8,000/family for In- <u>Network Providers</u> . \$20,000/person or \$40,000/family for Non- <u>Network Providers</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .

**Does this plan provide Minimum Essential Coverage? Yes.**
